LOCAL EXCHANGE RATES

I. General:

A service charge consisting of one or more of the charges shown in this section is applicable for the following activities undertaken at the customer's request:

A. Connections:

Service charges are in addition to all other applicable rates and charges associated with the service being provided.

II. Payment of Service Charges:

Payment of service charges for initial establishment of service may be required prior to the establishment of service.

The charges specified herein do not contemplate work begun being interrupted by the customer. If the customer interrupts work once begun, a charge in addition to the specified charges will be made equal to the additional cost involved.

III. Service Charges and Application:

A. Service Ordering Charge:

The service order activity is classified as either initial, subsequent, or record change. The charges are applicable for work done in receiving, recording and processing information necessary to execute each customer request for connections of service (initial order charge applies), to each order for a move, change, or addition to existing service (subsequent order charge applies) or to each requested change which only involves changing the Company's records (record change order charge applies). A non-published number charge applies to the initial ordering of a non-published telephone number.

III. Service Charges and Applications: (Continued)

A. Service Ordering Charge: (Continued)

A single service order will be issued for all work or service ordered to be performed or provided at the same time on the same premises. Service ordering charges apply separately where business and residence service are located on the same premises.

B. Line Connection Charge:

The line connection charge is applicable for work done in the Central Office and elsewhere in association with providing an access line from the Central Office to the customer's premises or making changes thereto.

One (1) line connection charge is applicable to the provision of each access line in association with any of the following services.

1. Individual Residence Service
2. Individual Business Service
3. Long Distance Terminals
4. Private Lines
5. Foreign Exchange Service

C. Repair and Service

Repair and service includes charges for serviceman coming to the customer's premises for labor on but not limited to the customer's equipment, wiring, and/or jacks.

A charge will be made when a check is presented in payment for services and is subsequently returned by the bank for insufficient funds.
